This will utilize lesson time until the Instructor determines it is safe to resume Client rider coaching.
- The Instructor reserves the right to terminate a lesson involving an intoxicated or unsafe Client. The Client will be held responsible for the full lesson fee.
- The Instructor reserves the right to require an adult to accompany a minor for the duration of the lesson.
